In pursuance of Commission of the Secretariat, Cabinet of Ministers of Ukraine, dated 10.07.2014 # 24489/1/1-14 and Commission of the Ministry of Ecology and Natural Resources of Ukraine dated 11.07.2014 # 1240/2-3/14 the State Ecological Inspection of Ukraine has considered the Letters of the Ukrainian National Committee under the International Chamber of Commerce dated 01.07.2014 # 462 and # 463 concerning the Meeting of the Interagency Working and Expert Groups for Implementation the "Single Window – Local Solution" Technology in the Operations Area of Pivdenna Customs House and Ports of Odessa Region and hereby inform you about the following:

The representatives of Derzhecoinspection of Ukraine have actively participated in the Meetings of the Interagency Working and Expert Groups for Implementation the "Single Window – Local Solution" Technology in the Operations Area of Pivdenna Customs House and Ports of Odessa Region since 2012, which took place in Kyiv in Odessa. In particular, the composition of the Interagency Working and Expert Groups includes Oleg Mykhailovych Zolotariov, Chief of Department for Ecological and Radiological Control at the State Border Checkpoints, the State Ecological Inspection of the Black Sea North-West Region.

For the purpose of providing for the electronic information and documents interchange between the state bodies authorised to perform the corresponding types of control at the state border checkpoints during the operations with goods and transport vehicles and business subjects operating in the sea port, and with a view of complying with the requirements of the Standard Process Scheme for Admitting across the State Border of Persons, road, water, rail and air transport vehicles and Goods Moved by the Latter, which was approved by Resolution of the Cabinet of Ministers of Ukraine on 21.05.2012 as # 451, the electronic digital signatures (EDS) have been obtained for the State Inspectors of Ecological Control Stations "Odessa Sea Commercial Sea Port" and "Commercial Sea Port 'Yuzhnyi", an agreement of information cooperation has been signed between the Derzhecoinspection of the Black Sea North-West Region and SE "Administration of Sea Ports of Ukraine", as well as an agreement on providing access to the Port Community Information System has been subscribed with the Data Processing Centre under LLC "PPL 33-35".

The State Ecological Inspection of the Black Sea North-West Region was involved in the development and coordination with other control bodies, which exercise their authorities in the territories of the marine checkpoints, of the Process Schemes for Admitting Persons, transport Vehicles and Cargoes at State Border Checkpoints of Ukraine for Sea Traffic in consideration of the implementation of the Port Community Information System (hereinafter – "PCIS") at the sea ports in accordance with Resolution of the Cabinet of Ministers of Ukraine dated 03.07.2013 # 553 "On Amendments to Resolution of the Cabinet of Ministers of Ukraine Dated 21 May 2012 # 451".

The procedure of free pratique implementation in the ports of Odessa Region is at its final stage, at present following the usage of an electronic order PCIS is being introduced in SE "OCSP", SE "ICSP" and SE "SCP 'Yuzhnyi'" within the framework of the Pilot Project "Single Window – Local Solution" and electronic digital signature by the officials of the border control authorities.

The "OCSP" Ecological Control Station has prepared the material and technical basis for launching of PCIS, actually, the System implementation is at the stage of consultations between the business subjects of foreign economic activity and control bodies.

On 12.03.2014 PCIS started to clear the transport vehicles moving in the ports, namely, the Ecological Control Station "Sea Commercial Port 'Yuzhnyi" began to apply free pratique to the foreign-going ships.

As at 05.08.2014 the State Ecological Inspection of the Black Sea North-West Region has coordinated the Draft Orders of the Odessa Border Unit "On Amendments to Orders of the Odessa Border Unit" and on approval of the Process Schemes for Admitting Persons, Transport Vehicles and Cargoes through State Border Checkpoint of Ukraine for International Sea Traffic "Vizyrka" and Checkpoints "Illichivsk Sea Commercial Port" and "Odessa Commercial Sea Port".
