Re: Ensuring implementation of Decision of the Meeting

In answer to your Letter dated 01.07.2014 # 462 concerning ensuring the implementation of the Decision of the Meeting of the Interagency Working and Expert Groups for Implementation of the “Single Window – Local Solution” Technology in the Operations Area of Pivdenna Customs and Ports of Odessa Region dated 19.06.2014 the Ministry of Agrarian Policy and Food of Ukraine hereby informs the following.

In accordance with the Letter of the Odessa Regional Service for the State Veterinary and Sanitary Control and Supervision for the State Border and Transport dated 27.07.2014 # 942 as at 27.08.2014 the following draft documents have been approved: the Process Scheme of Admittance across the State Border of Ukraine of Persons, Transport Vehicles and Cargoes through the Checkpoint “Sea Commercial Port ‘Yuzhnyi’” and through the Security Checkpoint “Vizyrka”; and amendments and additions to the Process Scheme of Admittance across the State Border of Ukraine of Persons, Transport Vehicles and Cargoes through the State Border Checkpoint for International Maritime Traffic “Odessa Commercial Sea Port”. After their approval the above mentioned Draft Process Schemes were returned for continuation of the coordination and approval procedure to the relevant sections of the Border Service of Ukraine.

In accordance with Law of Ukraine “On Veterinary Medicine” and Veterinary Requirements to the Objects of the State Veterinary and Sanitary Control and Supervision Imported in Ukraine approved by Order of the State Department of Veterinary Control and Supervision, Minagropolicy, dated 14.06.2004 # 71, and Procedure of Admittance across the State Border of Ukraine of Cargoes Controlled by the State Veterinary Medicine approved by Order of Chief State Inspector of Veterinary Medicine of Ukraine dated 27.02.1999 # 49 the import of the cargoes controlled by the State Veterinary Medicine Service into Ukraine shall be accompanied with the originals of Veterinary Certificates issued by the competent authorities of the country of origin.
