		According to the information of the Pivdenna Customs, Mindokhodiv, (Letter dated 19.09.2014 # 13617/15-70-51) as at 18.06.2014 the "Odessa-Port" Customs Checkpoint, Pivdenna Customs, Mindokhodiv, has accepted and processed in PCIS 96,738 work orders and electronic documents. Total number of containers entered in the System under electronic orders is 166,915 containers.	
		Within a period from 02.09.2013, since the beginning of the implementation of the "Single Window – Local Solution" pilot project that introduced the use of the program- information complex "Port Community Information System", the "Odessa-Port" Customs Checkpoint, Pivdenna Customs, Mindokhodiv, has accepted and processed in the System in question 60,031 work orders and electronic documents pertaining to the former. Total number of containers entered in the System under electronic orders is 103,701 units	
		438 freight forwarding companies, 16 agency organisations (marine agents) and 20 sea lines possessing the functioning electronic digital signature (EDS) obtained in accordance with the established procedure have joined PCIS.	
		The "Illichivsk" Customs Checkpoint, Pivdenna Customs, Mindokhodiv, in the Illichivsk Sea Commercial Port continues testing the customs procedures with the use of the software provided by PE "Illichivsk Container Terminal" within the framework of	

the "Single Window – Local Solution" Pilot Project. The electronic work orders are being issued alongside with the paper ones. Since 02.06.2014 in the said Port it has become mandatory for all freight forwarding companies to have their orders issued in the electronic form in parallel with the paper orders.	
As at 18.06.2014 The Customs Checkpoint "Illichivsk" Pivdenna Customs, Mindokhodiv, had accepted and processed 4,618 electronic orders for 10,872 containers of goods. At present all freight forwarding companies and agency organisation (maritime agents) are working with electronic orders.
