The Ministry of Infrastructure hereby inform about the following in connection of Letter of the Ukrainian National Committee of International Chamber of Commerce dated 10.02.2014 # 60 concerning regular Meeting of the Interagency Working Group for the “Single Window – Local Solution” Technology Introduction:

We propose to include Kostiantyn Anatoliiovych Savchenko, Deputy Director of Department for Coordination of Infrastructure Development and Tourism Policy, the Ministry of Infrastructure of Ukraine, in the composition of the Interagency Working Group for the “Single Window – Local Solution” Technology Introduction in Operations Area of the Pivdena Customs House and Odessa Region Ports. And at the same time to withdraw Sergii Oleksandrovych Medvedev, Chief Specialist of the Section for Development of Transport and Tourism Services Markets, Department for Coordination of Infrastructure Development and Tourism Policy, the Ministry of Infrastructure of Ukraine.

Besides, we propose to include Oksana Stepanivna Babii, Chief of the Section for Long-Term Development of Priority Transport Networks, Department for Coordination of Infrastructure Development and Tourism Policy, the Ministry of Infrastructure of Ukraine.

At the same time we inform that in the regular Meeting of the Interagency and Expert Groups for the “Single Window – Local Solution” Technology Introduction in Operations Area of the Pivdena Customs House and Odessa Region Ports, which will take place on 04.03.2014, the above mentioned experts and Olena Oleksandrivna Proskura, Deputy Director of International Cooperation Department, Chief of the Section for European Integration and International Organisations, will take part.

As to the activities that have been carried out by the Ministry of Infrastructure within the framework of the “Single Window – Local Solution” Pilot Project and the facilitation of the customs trade procedure facilitation in 2014 within the scope of implementing the Program of Economic Reforms for 2010-2014 “Prosperous Society, Competent Economy and Efficient State” let us advise the following.

In accordance with the Program of Economic Reforms for 2010-2014 “Prosperous Society, Competent Economy and Efficient State”, which was developed in pursuance of the task concerning renewal of economic growth and modernization of economy of the state set up by President of Ukraine, the facilitation, efficiency increase and speeding up of the customs clearance process is a priority line of the customs procedures reformation.

Taking into account the stated above, Resolution of the Cabinet of Ministers of Ukraine dated 19 June 2013 # 422-p “On Amendments to Resolution of the Cabinet of Ministers of Ukraine dated 8 April 2009 # 381” was adopted.

For the purpose of ensuring the realization of the provisions of the said Resolution Mininfrastruktury has prepared Draft Resolution of the Cabinet of Ministers of Ukraine “On Amendments to the Standard Process Scheme of Customs Control of Water Transport Facilities

of Carriers and Goods that are Transported by them at the State Border Checkpoints” concerning the settlement of the issues of the containers movement during mixed (combined) transits of goods. As at today the given project has been filed with the interested executive authorities for approval.

Within the framework of the “Single Window – Local Solution” Project the following activities have been carried out:

- standards providing for control authorities usage of the Single Window technology pending their functions performance have been entered in the Customs Code of Ukraine; and
- corresponding amendments to Resolution of the Cabinet of Ministers of Ukraine “Issues of Passing through State Border of Persons, Motor, Water, Railway and Air Transportation Vehicles of Carriers and Goods which are Transported by them" dated 21 May 2012 # 451 (Resolution of the Cabinet of Ministers of Ukraine dated 02.07.2013 # 553) were adopted by the Cabinet of Ministers of Ukraine.

The work on the organizational and technical implementation of the Project has been carried out concurrently.

Over 2012-2013 the information system was being developed and tested and the potential system users were being trained. With the assistance of Mindohodiv (Letter dated 28.08.2013 # 16471/7/99-99-24-01-09-17) beginning from 02.09.2013 the customs officers have carried out the customs clearance of containerized goods imported into the territory of Ukraine by water transport facilities and removed outside the Odessa Commercial Sea Port Checkpoint exclusively with the use of PCIS and the electronic documents (work orders) certified with the electronic digital signature.

Certificate of Compliance registered on 15.10.2013 with the Administration of the State Service of Special Communication and Information Protection of Ukraine as # 9065, which is valid until 15.10.2018, confirmed that the integrated system of information protection “Unified Port Community Information System” (AS(P)-PC) ensures the technical protection of information in Ukraine.

In pursuance of the requirements of Resolution of the Cabinet of Ministers of Ukraine # 451 (as amended by Resolution dated 02.07.2013 # 553) and for the purpose of introduction of PCIS at the Odessa Sea Port, SE “Administration of Sea Ports of Ukraine” has developed Agreement of Information Cooperation.

SE “Administration of Sea Ports of Ukraine” has already concluded Agreement of Information Cooperation with all state authorities entitled to carry out the corresponding control at the state border checkpoints (except for the Ministry of Revenue and Duties) and over 400 subject of economic activities.

Today Mininfrastruktury carries out the corresponding work with the Ministry of Revenue and Duties on joining the said Agreement of Information Cooperation.
