For the implementation of the Economic Reforms Program 2010-2014 “Wealthy society, competitive economy, efficient state” developed 17 December 2013 No. 2125/24657 registered in the Ministry of Justice of Ukraine “Procedure of electronic consignment notes of UMVS, CIM/UMVS, CIM for declaring of goods that are not excisable” (hereinafter – Procedure). When the

Procedure comes into force 10.03.2014 declaration and control for the movement of goods that are not excisable to the customs of destination will be performed according to the electronic consignment notes.

This Procedure also covers goods that are imported at the territory of Ukraine with railway transport and after the transshipment in the ports they are shipped further beyond the customs territory of Ukraine with sea (river) transport and for the goods that are transported from the customs territory of Ukraine with railway transport. In this regard at the border railway stations and in ports there is no need to handle the declarations for customs control in paper. This is one of the stages to implement paper document flow between the railways and ports and allows mutually use electronic order and electronic consignment note data
